

CAMPUS SEXUAL ASSAULT STUDENT BILL OF RIGHTS

Lancaster Bible College is committed to uphold these rights that are designed to ensure that students who experience sexual violence are supported and treated fairly throughout the reporting and resolution process.

1. **Rights for Reporting Parties: Reporting:** The right to make a report to local law enforcement and/or state police.

2. **Serious Treatment:** The right to have disclosures of sexual violence, including sexual assault, domestic violence, dating violence, and stalking, treated seriously.
3. **Decision Making:** The right to decide whether to disclose a crime or violation and participate in the conduct process and/or criminal justice process without pressure from the institution.

Rights for Reporting and Responding Parties:

1. **Fair Process:** The right to participate in a process that is fair, impartial, and provides adequate notice and a meaningful opportunity to be heard.
2. **Dignity and Respect:** The right to be treated with dignity and to receive courteous, fair, and respectful health care and counseling services from the institution.
3. **Non-Retaliation:** The right to be protected from retaliation by the institution, any student, the accused, and/or their friends, family, and acquaintances within the institution's jurisdiction.
4. **Minimal Repetition:** The right to describe the incident to as few institutional representatives as practicable and not be required to unnecessarily repeat a description of the incident.
5. **Advisor:** The right to be accompanied by an advisor of choice who may assist and advise throughout the Title IX process as outlined by the Policy.
6. **Support Person:** The right to be accompanied by a support person of choice who may assist and comfort throughout the Title IX Process as outlined by the Policy.
7. **Notice of Outcome:** Reporting and Responding parties shall be informed in writing of the outcome of any Title IX proceeding, including informal processes, investigation, and appeal process.
8. **Supportive Measures:** The right to be notified of resources and supportive measures, and methods for requesting them.

These include but are not limited to:

- Academic extensions or adjustments
 - Campus escort services
 - Changes in housing
 - Changes in on campus work schedules or locations
 - Counseling
 - Increased security or monitoring of certain areas of the campus
 - Modifications of class or activity schedules
 - Mutual restrictions on contact between the Parties
 - Provide information on how to access legal assistance, victim advocacy and immigration/visa assistance
9. **Appeal:** The right to access at least one level of appeal of a determination for any of the following reasons:
 - o Procedural irregularity that would change the outcome;
 - o New evidence that would change the outcome and that was not reasonably available when the determination of responsibility was made; and
 - o The Title IX Coordinator, investigator, or adjudicator had a conflict of interest or bias for or against complainant or respondents generally or the individual complainant or respondent that affected the matter's outcome.
